Outdoor inspections and indoor inspections can be performed with a limit of one person onsite. Third party inspections will be accepted.
- **Code Enforcement**
Code Enforcement has been temporarily suspended at this time with the exception of reinspection of ongoing cases, egregious cases, and tall grass enforcement (limited basis).
