The locality was considered for the award of an **FY-2021 VFIRS Hardware Grant** from the Commonwealth's FIRE PROGRAMS FUND. Applications were reviewed by the Virginia Fire Services Board (VFSB), and awards were approved at the full VFSB meeting in October 2020. As such, the locality has been awarded a grant of \$\frac{\$700}{}\$ to purchase a computer in accordance with the program specifications for VFIRS for the following Fire Department(s):
