

A RESOLUTION NO. 22-18

Approving a Project Service Agreement for Municipal Solid Waste (MSW) Collection and Disposal Services with the Central Virginia Waste Management Authority.

WHEREAS, the City's current agreement for Municipal Solid Waste (MSW) collection and disposal services with the Central Virginia Waste Management Authority (CVWMA) expires on June 30, 2022; and

WHEREAS, CVWMA has entered into an agreement with Waste Management of Virginia, Inc. to provide MSW collection and disposal services for the City of Colonial Heights for a seven year period beginning on or about July 1, 2022 and ending on June 30, 2029; and

WHEREAS, it is appropriate for the City to enter into an agreement with CVWMA specifying that CVWMA, with Waste Management of Virginia, Inc. as its contractor, shall provide MSW collection and disposal services for the City for the above-mentioned seven-year period; and

WHEREAS, the attached Project Service Agreement for Municipal Solid Waste (MSW) Collection and Disposal Services, which is made a part of this resolution, provides for the needed MSW collection and disposal services beginning on or about July 1, 2022, and ending on June 30, 2029; NOW, THEREFORE,

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF COLONIAL HEIGHTS:

1. The attached Project Service Agreement for Municipal Solid Waste (MSW) Collection and Disposal Services with CVWMA is approved, and the City Manager is directed to sign the Agreement.
2. This resolution shall be in full force and effect upon its approval.
