

AN ORDINANCE NO. 22-22

Approving a Right of Way (easement) Agreement with Virginia Electric and Power Company d/b/a Dominion Energy Virginia.

WHEREAS, Virginia Electric and Power Company d/b/a Dominion Energy Virginia (“Dominion”) relocated some of its utility poles and lines in 2012 when the City purchased multiple parcels of property from the former Colonial Heights Baptist Church to erect the current Courthouse located at 550 Boulevard; and

WHEREAS, the above-referenced utility poles and lines are located along the Boulevard and Dupuy Avenue across City property known as Parcel Identification Numbers 3000050000A, 3000030A0A, 3000030A00B, and 30000200001 in the records of the Colonial Heights Circuit Court; which are part of the combined Parcel Identification Number of 300001E0000 in the records of the Colonial Heights Assessor’s Office; and

WHEREAS, Dominion Energy Virginia wishes to enter into a Right of Way (easement) Agreement with the City, a copy of which is attached to and made a part of this Ordinance; which Agreement includes a plat depicting the requested easement; and

WHEREAS, the Council properly advertised notice of a public hearing on this Ordinance and the approval of the easement and held such a public hearing; and

WHEREAS, the Council believes that it is appropriate to grant Dominion the requested easement; NOW, THEREFORE,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLONIAL HEIGHTS:

1. The attached Right of Way Agreement is approved; and Douglas E. Smith, City Manager, is hereby authorized to enter into the Agreement with Virginia Electric and Power Company d/b/a Dominion Energy Virginia, in which the City grants a variable width easement for 40 years along City owned property known as Parcel Identification Numbers 3000050000A, 3000030A0A, 3000030A00B, and 30000200001 in the records of the Colonial Heights Circuit Court, which are part of

the combined Parcel Identification Number of 300001E0000 in the records of the Colonial Heights Assessor's Office.

2. This ordinance shall be effective upon approval on second reading.
