

AN ORDINANCE NO. 23-3

To amend § 51-54 of Chapter 51, Personnel Policies and Grievance Procedure, of the Colonial Heights City Code, to include Juneteenth as a City Holiday.

THE CITY OF COLONIAL HEIGHTS HEREBY ORDAINS AS FOLLOWS:

1. Section 51-54 of Chapter 51, Personnel Policies and Grievance Procedure, of the Colonial Heights City Code is amended as follows:

**§ 51-54 Holidays.**

A. Authorized holidays.

- (1) Except as otherwise provided herein, the holidays authorized to be observed are the following in each year:

- (f) Third Monday in June (Juneteenth).
- (~~g~~) Fourth day of July (Independence Day).
- (~~g~~h) First Monday in September (Labor Day).
- (~~h~~i) Second Monday in October (Columbus Day).
- (~~i~~j) Eleventh day of November (Veterans Day).
- (~~j~~k) Fourth Thursday in November (Thanksgiving Day) and the Friday following.
- (~~k~~l) Twenty-fifth day of December (Christmas Day) and either the last workday before or the next workday after, as determined annually by the City Manager.
