


### **8. Reading of Manner Addressing Council**

**ANY MEMBER OF THE PUBLIC** addressing the Council shall approach the lectern, give his name and address in an audible tone of voice for the record, **AND ADDRESS THE COUNCIL AS A BODY RATHER THAN SPEAK TO ANY MEMBER.** Unless further time is granted by the Council, **ANY MEMBER OF THE PUBLIC** shall address the Council for a maximum of five (5) minutes, regardless of the number of issues he desires to discuss. **PROVIDED** however, that the main proponent of any application, petition, or plan that is the subject of a public hearing shall be allowed to address the Council initially for a maximum of ten (10) minutes and later in rebuttal for a maximum of three (3) minutes.



#### **A. AN ORDINANCE NO 19-19**

*(First Reading) Amending § 244-14 of Chapter 244, Solid Waste, of the Colonial Heights City Code, by changing the required location of solid waste and recycling cans and containers, providing an exception for the location of solid waste and recycling cans and containers for the owners or tenants of certain multifamily housing, and providing an exception for those customers receiving certain assistance in rolling cans and containers to the street and rolling them back toward a residence.*



## § 244-14 SUPERVISION OF COLLECTION; CANS AND CONTAINERS PREVIOUS ORDINANCE

Except for the time period specified in this subsection that a can or container may remain in the City right-of-way, all solid waste and recycling cans and containers **shall remain in a location behind the front plane of the residence or business.**









#### ***B. AN ORDINANCE NO 19-23***

*(First Reading) Amending §§ 98-42 and 98-43 of Chapter 98, Animals, of the Colonial Heights City Code; adding new §§ 98-42.1 and 98-43.1 to Chapter 98; and amending § 258-500.04 of Chapter 286, Zoning, of the City Code, all relating to allowing up to three female chickens, and associated pens or coops, to be kept as an accessory use to a primary residential use type.*


## Planning Commission Resolution 19-7

Recommending the approval of **Ordinance 19-23**, to amend § 286-500.04 of City Code Chapter 286, “Zoning”, to allow the keeping of up to three female chickens as an accessory use on residentially-zoned property, subject to complying with various provisions in City Code Chapter 98, “Animals”. The ordinance specifies that: (i) all chickens shall be kept at all times within an enclosed area in a backyard; (ii) any structure, pen, or coop for the keeping of chickens shall be a minimum area of 10 square feet per chicken; (iii) roosters, ducks, and geese shall not be kept anywhere in the City; and (iv) an Animal Control Officer may inspect the area in which chickens are kept to ensure compliance with the law.

Planning Commission recommended disapproval (5-1-1).

## **Transitional Office**


The primary uses in the Transitional Office classification are low-to-medium intensity professional, business and administrative offices, and medical and dental clinics that are compatible with adjacent residential uses and serve as separation between residential areas and nearby commercial or other higher intensity land uses or features. The scale and intensity of such office uses may vary depending on the density and type of residential uses they are intended to buffer. The zoning district that would accommodate this land use category is RO (Residential Office) and PUD (Planned Unit Development).

## **Community Commercial**

Community Commercial - The primary uses in the Community Commercial classification include office, retail, personal service and other commercial and service uses, intended to provide the shopping and service needs of residents of a number of nearby neighborhoods and other City residents. This category includes a range of uses with vehicular access and orientation, but that are also compatible with nearby residential areas. The zoning district that would accommodate this land use category is BB (Boulevard Business) and in some instances GB (General Business).




## City of Colonial Heights Zoning Districts



## **Ordinance No. 19-28**

### **History**

#### **October 15, 2019 City Council Special Meeting**

Planning Staff presented an overview of donation bins in the City, a list of localities that regulate donation bins and the typical regulations associated with donation bins. City Council voted (5-2) to move forward on an ordinance to prohibit donation bins.

#### **November 5, 2019 Planning Commission Meeting**


Planning Commission recommended (6-0-1) the approval of Ordinance 19-28, amending § 286-200 of Chapter 286, Zoning, of the Colonial Heights City Code by adding a definition of “donation collection bin” and adding a § 286-530.26 to Chapter 286, prohibiting the placement or location of donation collection bins anywhere in the City.
