A. AN ORDINANCE NO 20-22

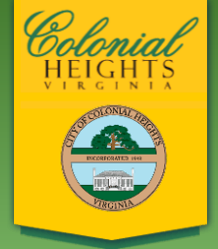
A. AN ORDINANCE NO 20-FIN-17

To amend the Emergency Response Fund Budget for the fiscal year beginning July 1, 2020 and ending June 30, 2021, to appropriate the aggregate amount of \$67,252 which includes: 1) \$13,735 in prior year encumbrances; and 2) \$53,517 in CARES funds from the state Board of Elections for the November election.

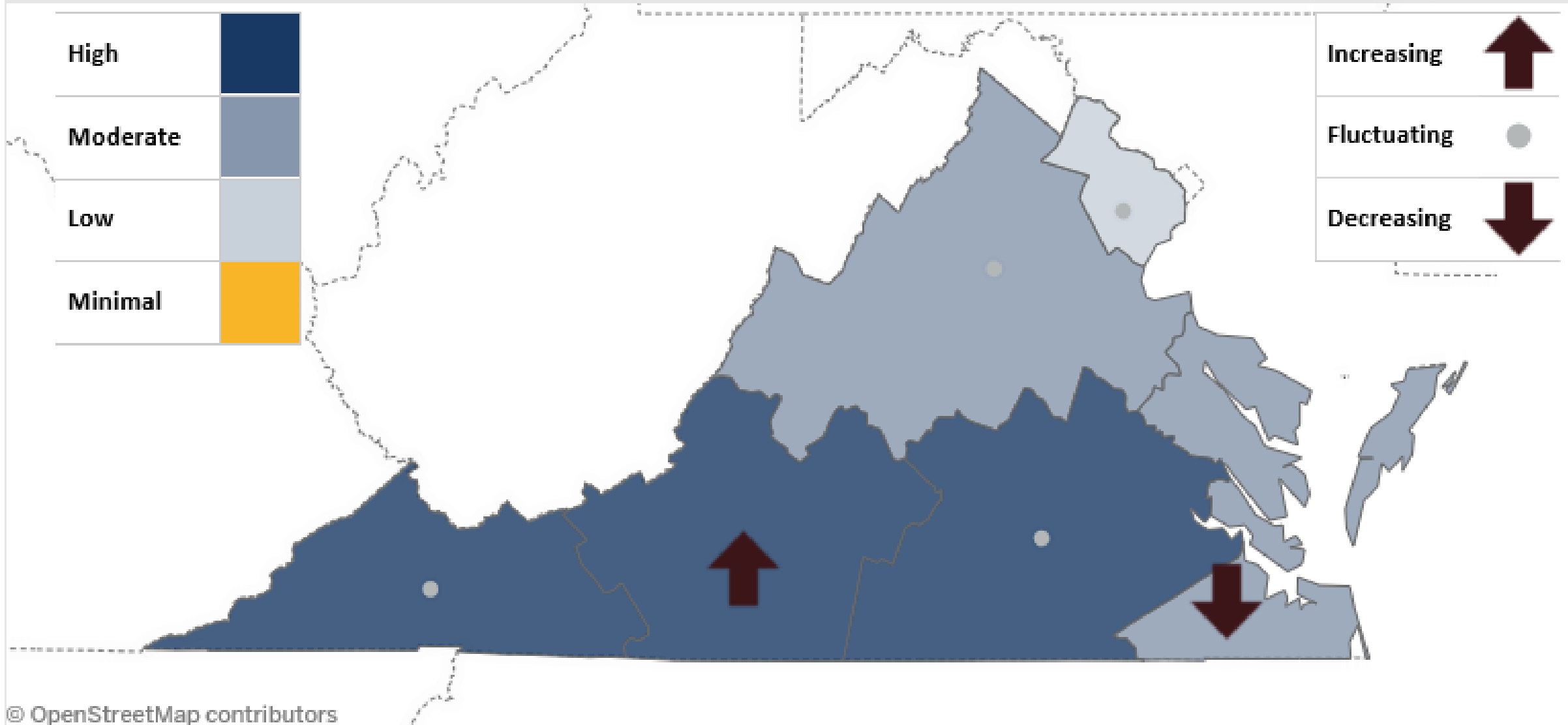

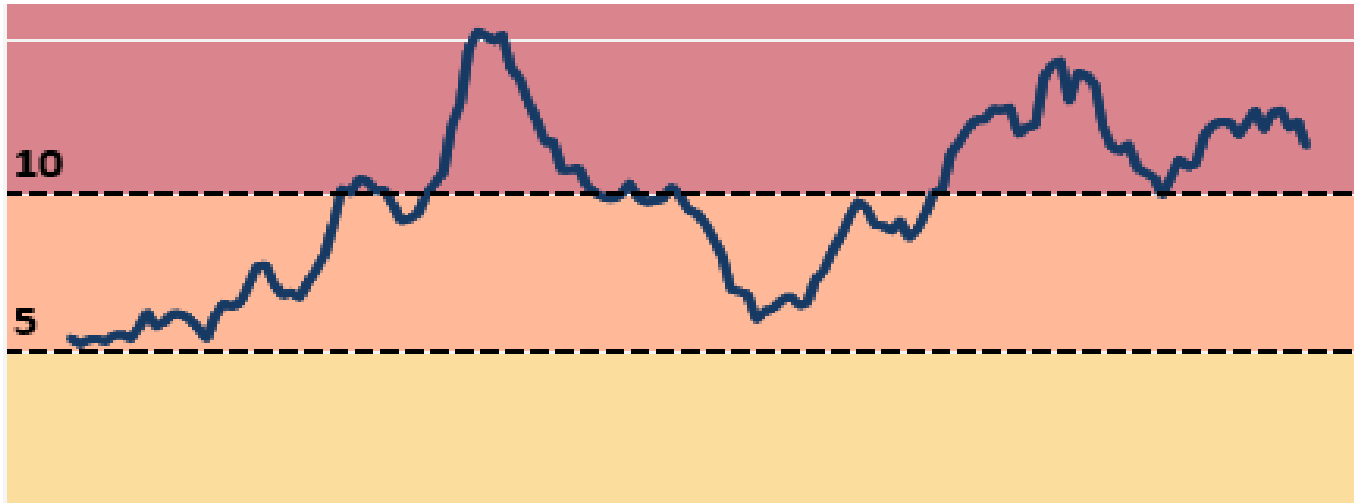

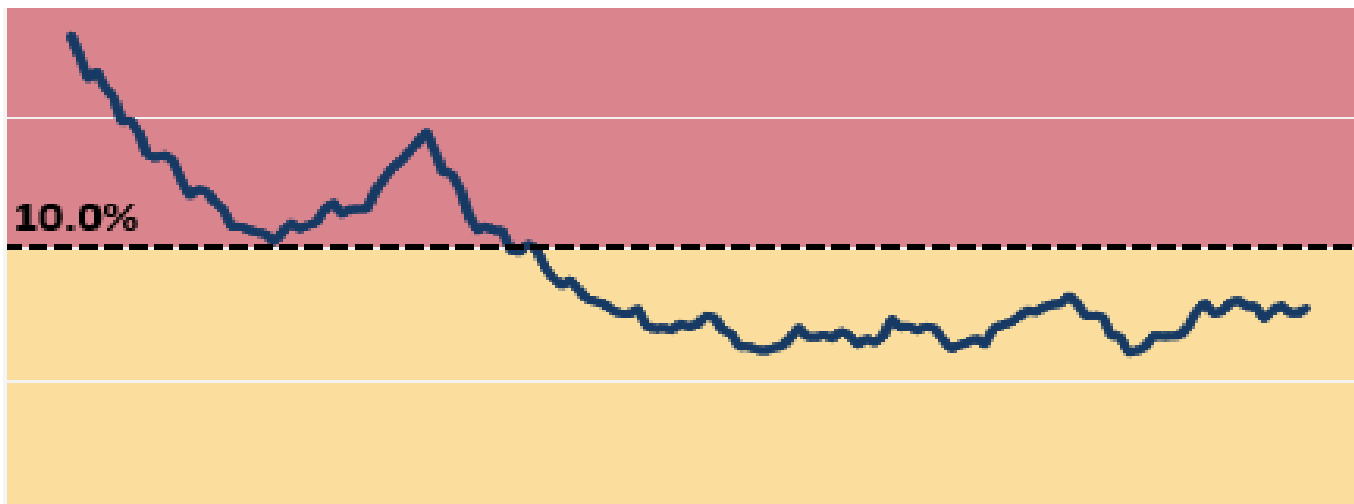
Cases have been decreasing for 5 days. This does not exceed the threshold of 14 days, so cases are considered to be fluctuating.

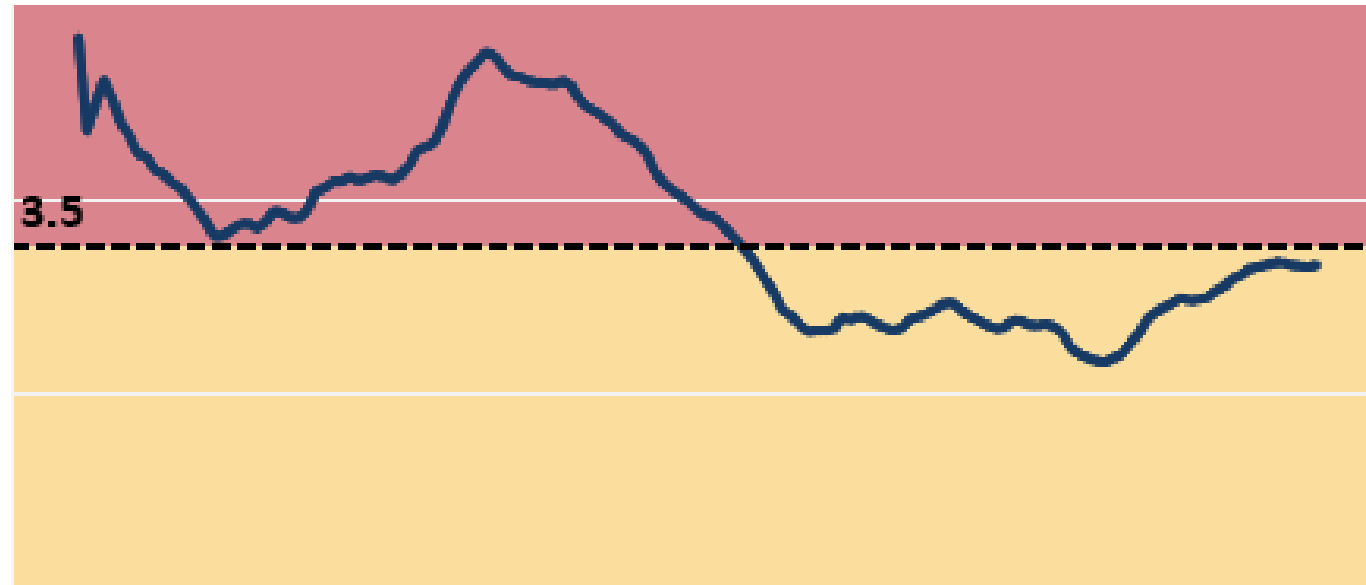

ICU hospitalizations have been increasing for 26 days. This exceeds the threshold of 14 days, so the number of ICU hospitalizations is considered to be **increasing**.

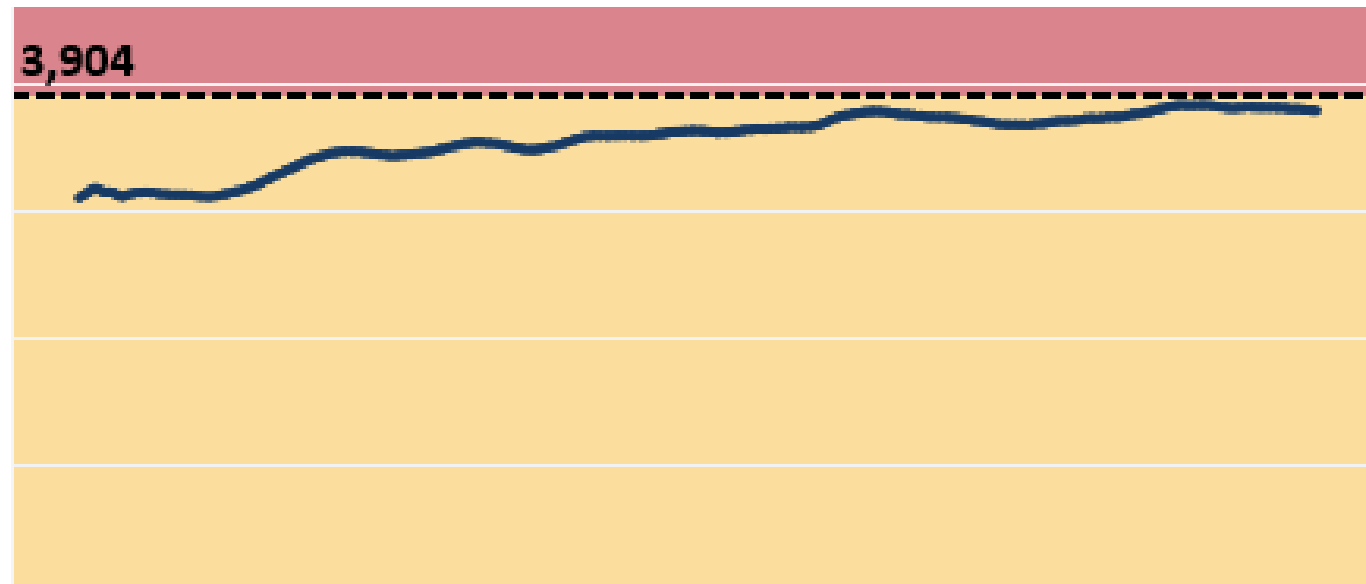


HOSPITAL BEDS

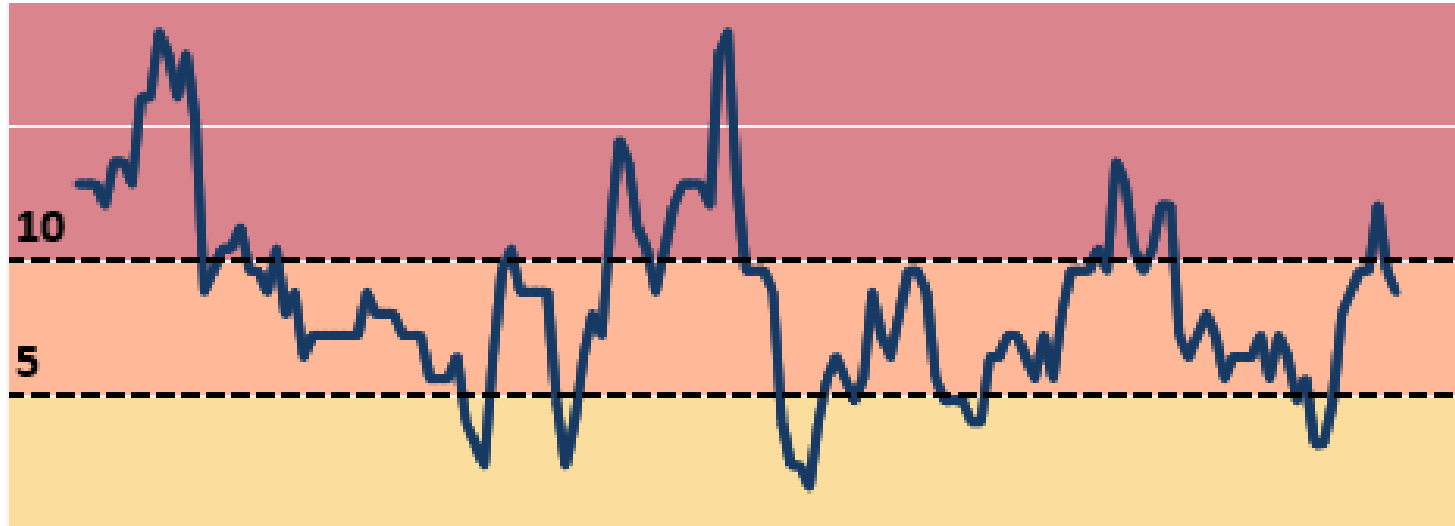

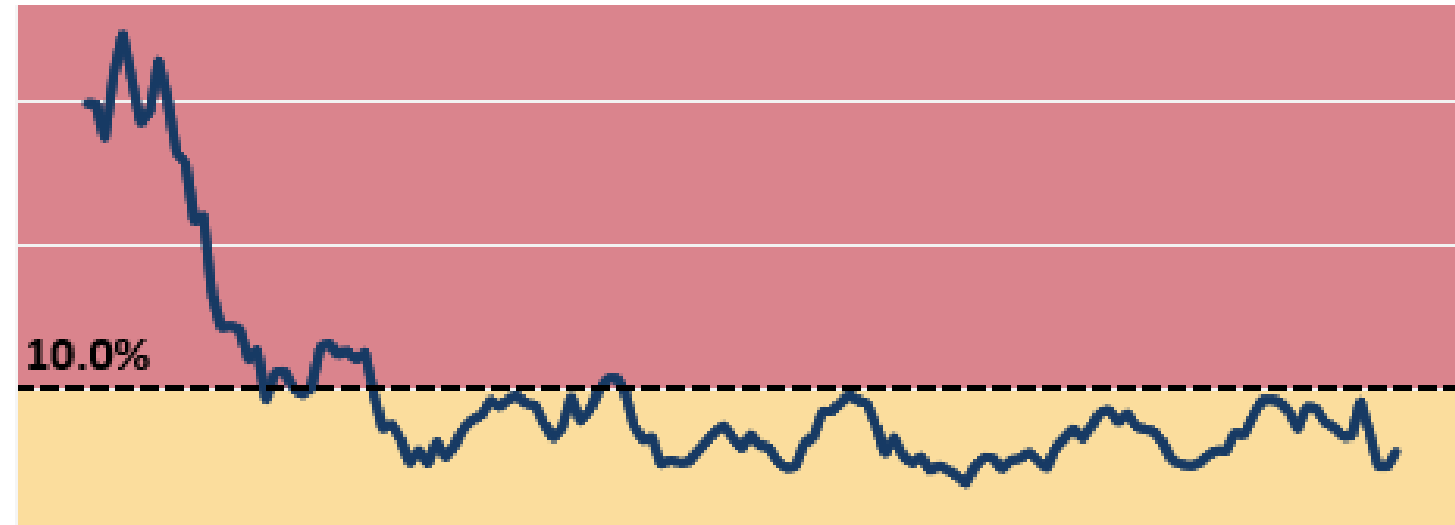
Cases have been increasing for **11 days**. This does not exceed the threshold of 14 days, so cases are considered to be fluctuating.
