AN ORDINANCE NO 23-17 (UNANIMOUS PASS)

(Second Reading) Amending § 273-37 of Chapter 273, Vehicles and Traffic, of the Colonial Heights City Code by authorizing the Chief of the Department of Fire and EMS, or his designee, to issue a citation for the illegal paring of a motor vehicle in a fire lane; and to increase the penalty from \$20 to \$50 for numerous parking violations.

AN ORDINANCE NO. 23-FIN-13 (UNANIMOUS PASS)

(Second Reading) To amend the General Fund Budget for the fiscal year beginning July 1, 2023, and ending June 30, 2024, by appropriating \$27,224, consisting of: 1) \$1,500 to the Police Department from the American Legion; 2) \$12,500 in grant funds to the Police Department from HEAT (Help Eliminate auto theft); 3) \$1,600 to the Police Department in state asset forfeiture funds; 4) \$8,000 to the Library from the Library Donation Fund balance; 5) \$1,381 to the Office on Youth from carryover Shoe Fund balance; 6) \$641 to the Office on Youth from lemonade stand donations; 7) \$1,602 to the Office on Youth from

FY 23 carryover Youth Advisory Council funds along with a transfer of \$2,250 from the Contribution and Subsidies budget.

Authorizing the City Manager to execute a First Amendment to Service Agreement among South Central Wastewater Authority, Dinwiddie County Water Authority and the Incorporating Subdivisions.
