Colonial Heights Police Department 2024 Organizational Chart






Top Ten Calls for Service


2024 Overview

- In 2024, the Colonial Heights Police Department responded to 26,167 calls for service. This was an increase of approximately 578 calls for service in comparison to 2023.

2024 Calls for Service by Month





The following pages contain statistical information that we report to the National Incident-Based Reporting System (NIBRS) regarding offenses that occur and arrests we make in Colonial Heights. Incidents and arrests depending on their nature are classified in two main categories, or Group A and B Offenses.

Group A offenses are the more serious crimes such as Murder, Rape, Robbery, etc. and as a result, NIBRS requires that we report both offenses and arrests for these categories.





2024 Group A Crimes with Clearance Rates



3 Year Comparison: 2022-2024




Crimes Against Society represent society's prohibition against engaging in certain types of activity and are typically victimless crimes.



2024 Statistical Overview: Group B Offenses

Group B Offenses tend to be minor in nature, such as Curfew/Loitering/Vagrancy Violations, Disorderly Conduct, Driving Under the Influence, etc., and as a result, NIBRS requires that we only report arrests for these categories.


2024 Breakdown of Traffic Offenses



Accident Comparison by Type 3 Year Comparison: 2022-2024


Accidents that are “reportable” are generally ones that occur on the roadway and involve damage over \$1500, injury, or a vehicle is towed away.

Non-reportable are minor in nature and generally involve an exchange of driver contact and insurance information.

10 Year Comparison: 2014-2024




Behavioral Health Emergency Calls


Over the past several years, agencies across the country have seen a significant increase in calls for mental health referred to as “behavioral health emergencies”. We ourselves are experiencing the same increase in calls and related demands on our agency. In 2014, we responded to 103 mental health calls. This required the equivalent of over fourteen and a half days (24 hours each) of an officer’s time, which includes time on scene, transportation and wait times for mental health evaluations at medical facilities. In 2024, CHPD responded to 318 mental health calls, which required the equivalent of 66.9 days or more than two months to complete.


2023 vs. 2024




Use of Force - Reason for Contact

Type of Force Used on Officer by Civilian




Agency Activities: Use of Force


- The Colonial Heights Police Department records every use of force. For context, if two officers on the same call display their firearm, it is recorded as two uses of force. Out of 26,167 calls for service in 2024, a total of 61 uses of force were recorded. Compared to 2023, there was a decrease in one use of force in 2024.

Agency Activities: Vehicle Pursuits




Type of Pursuit




Reason for Pursuit

Suspect Armed





Agency Activities: Complaints


Complaints made against an officer, not criminal in nature, are investigated and will generally be concluded with one of four possible outcomes:

- Unfounded – The allegation made is false, and the evidence shows that misconduct or inappropriate behavior did not occur, or the named employee was not involved.
- Exonerated – The facts suggest that the alleged incident did occur, but that the employee's actions were lawful, proper and consistent with department policy and directives.
- Not Sustained – Unable to verify the truth of the matters under investigation.
- Sustained – The action of the person accused was inconsistent with department policy or directives.

In 2024, Colonial Heights Police Officers responded to 26,167 calls for service.
