ADOPTION OF:

AN ORDINANCE NO. 08-1 (As Amended)(Second Reading). Establishing the 2008 real estate tax rate at \$1.10 per \$100 assessed value.

AN ORDINANCE NO. 08-3 (First Reading). To amend and reordain §§273-37 through 273-40 of Chapter 273, Vehicles and Traffic, of the Colonial Heights City Code, by changing the procedure by which the City collects payment for delinquent parking citations and changing the procedure by which persons charged with violations may contest their citations.

AN ORDINANCE NO. 08-FIN-2 (Second Reading). To amend the General Fund for the fiscal year beginning July 1, 2007, and ending June 30, 2008, to appropriate \$2,498 to Public Safety to assist the Police Department with funding for the Adopt-A-Cop Program; \$9,923 to Public Safety for the purchase of a Fire Extinguisher Simulator and two (2) complete IFSTA Training Libraries for the Fire Department; and \$7,000 to Parks and Recreation for improvements to Shepherd Stadium fencing, a Fort Clifton sign, a swing set for White Bank Park, and repairs to the Amphitheater, such funds coming from donations and grants; and to appropriate \$283,000 to Legislative, Community Development and Transfers for economic development, unanticipated expenditures, and transfers to other funds, such funds coming from Contingencies.

To also amend the Capital Projects Fund Budget for \$103,198 in completed projects and to appropriate these funds and \$800,000 from General Fund surpluses to General Government and Recreational projects.

To also amend the Solid Waste Management Fund to reduce \$180,000 in anticipated refuse dumping fees, with such funds being replaced from General Fund contingency appropriations.

AN ORDINANCE NO. 08-FIN-3 (First Reading). To amend the General Fund for the fiscal year beginning July 1, 2007, and ending June 30, 2008, to appropriate \$7,100 to Judicial for the purchase of five (5) AED's (Automatic External Defibrillators), an AED trainer, and related equipment by the Sheriff's Department and \$19,125 to Public Safety for the purchase of replacement mobile data computers by the Police Department in order to further the City's participation in LInx (Law Enforcement Information Exchange); such funds coming from grants.

To also amend the Capital Projects Fund Budget to transfer \$150,000 from Bruce Avenue Phase I to Boulevard Widening to reflect current estimates.

A RESOLUTION NO. 08-6. Resolution of intent to join the Urban Construction Initiative.

A RESOLUTION NO. 08-7. Authorizing the City Manager to enter into a Special Project Service Agreement with the Central Virginia Waste Management Authority for an Appliance and Scrap Metal Hauling and Recycling program.
