TRAFFIC SIGNAL UPGRADES TO RELIEVE CONGESTION AND IMPROVE PEDESTRIAN SAFETY

The City has substantially completed the construction of a first-phase project to upgrade equipment, hardware and software for five traffic signals located in the North Boulevard corridor – Colonial Heights’ “Main Street.” Intersections included in this project are: Temple Avenue, Ellerslie Avenue, Newcastle Drive, Lakeview Avenue and Sherwood Drive. The contract cost of the project is approximately \$420,000, which is 100% federally-funded.

This is a crucial step in linking each traffic signal to an on-street master controller and to City computers via various communication technologies. These technologies allow the City to modify traffic signal timings as necessary to provide for more efficient traffic flow.

Our long-term strategy for the Boulevard is to create a streetscape with continuous sidewalks and pedestrian facilities throughout its entire length. This first-phase project not only upgrades vehicular traffic signals but also provides pedestrian signals, crosswalks and curb ramps. Pedestrian facilities are necessary to comply with American with Disabilities Act (ADA) requirements.

Traffic signal coordination and modernization projects in the City provide the following benefits:

- ★ New traffic control equipment to reduce the time and cost of maintaining aged and deteriorated equipment.
- ★ New pedestrian facilities to improve safety and comply with current ADA regulations.
- ★ Improved signal coordination between City- and State-owned signals to reduce travel time and delays.
- ★ Ability of City staff to monitor and adjust signal timings during peak travel hours, special events, and detours caused by emergency incidents on Interstate 95.
- ★ Improved response time for emergency vehicles to move through congested travel corridors.

CITY COUNCIL APPOINTS NEW CITY MANAGER

At its Regular Meeting of October 12, 2010, City Council formally approved the appointment of Thomas L. Mattis as the new Colonial Heights City Manager. Mr. Mattis has achieved a successful and diversified career as a City Manager over the past 28 years. Mr. Mattis most recently served as City Manager for the City of Kyle, Texas for the past 8 years. Kyle experienced dramatic growth and development during Mattis’ tenure, increasing its population from 5,000 residents in 2002 to its current estimated population of nearly 30,000. In preparing for the growth of Kyle, Mr. Mattis was instrumental in securing infrastructure upgrades and positioning the City to be able to manage the growth. He has negotiated a wide range of successful public-private partnerships facilitating local job growth and business development. Prior to being the City Manager of Kyle, he served as the Municipal Administrator for 10 years with Waterville, Ohio. Mr. Mattis has a Bachelor of Arts in Political Science/American History from Bowling Green State University. He has also obtained many certifications from continuing education courses and received awards from various business associations and civic groups. Mr. Mattis and his wife Mary Ann will complete their relocation to Colonial Heights in the near future. CITY COUNCIL APPROVES CHANGE IN ENFORCEMENT OF TALL GRASS CUTTING



Even though the drought has slowed the growth of grass in the City, City Council recently reviewed a revised policy on enforcement of the City's Tall Grass regulations.

Violators of the ordinance were previously given a 10 day notice to get the grass cut. If that didn't occur, then a five day notice was issued before any enforcement could be carried out.

The new policy replaces the 5 day notice letter with a 48 hour sticker that will be placed on the property. If compliance has not been achieved after the 48 hour period, then the City will have the grass cut and the bill charged to the property owner. If the bill is not paid in 30 days, a lien will be placed on the property. This new policy is now in effect.

NEW RENTAL INSPECTION DISTRICTS PROPOSED



The City Council recently heard a report from the Department of Planning and Community Development on the completion of Phase 2 of the Rental Inspection Program. To-date, there have been over 1,250 inspections made and 1,047 four year certificates issued in the Violet Bank/Flora Hill; Shepherd Stadium, Westover Snead and Toll House Districts. In 2011, the initial rental units inspected will be reinspected as their four year anniversary is achieved.

In addition to summarizing the work completed to-date, staff has recommended that three additional areas be added. These are the following neighborhoods: Oak Hill District, Lakeview District and Ellerslie District. City Council will be holding a public hearing in the near future to consider these additional neighborhoods.

Smoke Alarms are a very important means of preventing house fire fatalities by providing an early warning signal so you and your family can escape. These alarms are one of the best safety devices you can purchase to protect yourself, your family, and your home.

Installing and maintaining a working smoke detector in your house, cuts your chances of dying in a home fire in half. Colonial Heights Fire & EMS recommends at least one smoke alarm on every level of your home, outside all sleeping areas, and in all bedrooms. **Smoke Alarms: A Sound You Can Live With.**



ABSENTEE VOTING IN COLONIAL HEIGHTS

Absentee voting is available for registered voters who will not be in the City on Election Day, or who are unable to go to the polls for one of the following reasons. An application for an absentee ballot is available at the Registrar's office or to download at www.sbe.virginia.gov.

Valid reasons for voting absentee are:

- Students at institutions of higher learning, and their spouses
- Absent for business purposes
- Absent for personal business or vacation
- Scheduled to work at one's workplace at least 11 of the 13 hours the polls are open
- First responder (law enforcement, fire fighters, emergency techs)
- Unable to get to the polls because of physical disability or illness
- Pregnancy
- Caretakers of confined family members
- Awaiting trial and under confinement
- Serving time for misdemeanor convictions
- Religious conflicts
- Active duty uniformed services or merchant marine personnel and their dependents
- Regularly employed outside the U.S. and dependents

Neighborhood Leaf Removal Service Fall 2010/Winter 2011



Convenient Service during Fall Season

The City of Colonial Heights Department of Public Works is pleased to announce that convenient leaf removal services will be provided in city neighborhoods again this year. Each fall, residents collect and stockpile loose leaves along city streets, which city crews remove and make available to local recycling businesses. During the 2009 season, city crews collected approximately 3,000 cubic yards of leaves.

Year Round Service Option

Bagged leaves are collected year round and may be placed at the curbside on regular trash collection days. The limit per collection day is 30 bags, each weighing no more than 50 pounds.

Neighborhood Service Areas

This year leaf removal operations will occur in three main service areas, each consisting of three to four neighborhoods. Figure 1 shows the service areas and schedules. Signs will be installed on adjacent thoroughfares to let residents know in advance when service is scheduled in their area. Please note that the time for service in each area is subject to change depending on inclement weather conditions and other events beyond the City's control.

Scheduled Time of Service

Leaves will be collected and removed during the hours of 7:30 AM and 3:00 PM, Monday through Friday, beginning November 08, 2010 and ending January 28, 2011.

Preparing Leaves for City Collection

Residents are asked to place leaves along street frontages and roadsides one week before service is scheduled to begin in their neighborhood. No leaves will be removed except during regularly scheduled times. Leaves that are not placed before regularly scheduled removal times will be removed during the next regularly scheduled service in the area. City crews cannot remove leaves from private property.

Avoid Mixing Leaves with Other Debris

Residents are asked to keep leaf piles free of tree branches, lumber, steel, rock, concrete or other debris. Hard objects mixed with leaves are hazardous and may damage leaf vacuum equipment causing unnecessary time and expense to repair or replace.

Neighborhood Parking During Leaf Removal Service

Residents can assist city leaf removal operations by keeping parked vehicles clear of leaf piles. The use of off-street parking is encouraged wherever available. "No Parking" signs may be used to restrict parking on neighborhood streets while city crews remove leaf piles. To avoid damaging personal property, city crews will not rake leaf piles out from under or between parked cars.




