**AN ORDINANCE NO 13-FIN-13**

(Second Reading) To amend the General Fund Budget for the fiscal year beginning July 1, 2013, and ending June 30, 2014, to appropriate funds in the aggregate amount of \$332,590, which consists of \$3,965 in funding from the VA Municipal League for Public Safety equipment; \$3,891 of grant funds from Byrne Justice Assistance Grant to

purchase Public Safety equipment and training; \$46,293 of Criminal Justice Grant Funds and additional matching funds for an Elementary School Resource Officer; \$600 from the proceeds of the CHARTS Legacy Bench Program to reimburse City expenditures; and reappropriation of \$277,841 in encumbered FY 2013 funds as required under the Governmental Accounting Standards Board (GASB) for budgetary reporting purposes. To amend the Capital Projects Fund Budget to appropriate \$5,461 from additional Sunshine 5k race proceeds to the Flora M. Hill Park playground equipment.

(First Reading) To amend the General Fund Budget for the fiscal year beginning July 1, 2013, and ending June 30, 2014, to appropriate \$144,581, which consists of \$112,381 in additional State funding changes, grants, and intergovernmental reimbursement; \$1,000 in donated funds from Wal-Mart for the Kids After-School Program for program supplies; \$6,000 in grant funds from DMV to the police for selective enforcement of alcohol offenses; \$25,200 from Restricted Funds for purchase of a street crime van and vehicle repair.
