ADOPTION OF:

AN ORDINANCE 16-1 (UNANIMOUS PASS)

(Second Reading) To change the land use classification of an approximate 0.13 acre tract consisting of parcel identification number 3000010E23A on the Land Use map, which is part of the City Comprehensive Plan (i.e. Master Plan), from "Residential – Singl Family" to "Transitional Office".

AN ORDINANCE 16-2 (UNANIMOUS PASS)

(Second Reading) To change the zoning classification of an approximate 0.13 acre parcel with parcel identification number 3000010E23A from "RL Low Density Residential District" to "RO Residential Office District" and to amend the Zoning Map accordingly.

AN ORDINANCE NO 16-3 (UNANIMOUS PASS)

(Second Reading) To change the zoning classification of an approximate 1.12 acre site with parcel identification number 30000200001 and a physical address of 512 Boulevard from "RL Low Density Residential District" to "BB Boulevard Business District" and to amend the Zoning Map accordingly.

AN ORDINANCE 16-FIN-2 (UNANIMOUS PASS)

(Second Reading) To amend the General Fund Budget for the fiscal year beginning July 1, 2015, and ending June 30, 2016, to appropriate funds in the aggregate amount of \$1,276,001, which consists of \$700,957 in proceeds to the School System from the sale of the former City Courthouse, for the renovation of high school classrooms; \$450,004 for City Capital Improvement Projects; and \$125,000 from current and prior donations for the renovation and addition to the City Animal Shelter.

To amend the Capital Projects Fund Budget to appropriate \$575,004 from General Fund Transfers for Animal Shelter Expansion (\$225,000), Violet Bank Museum renovation (\$100,000), and Temple Avenue Sewer Line replacement and right-of-way acquisition (\$250,044); and to transfer \$500,000 from the Bruce Avenue Drainage Project to Temple Avenue Sewer Line replacement.

AN ORDINANCE NO 16-FIN-3 (UNANIMOUS PASS)

(Second Reading) To amend the General Fund Budget for the fiscal year beginning July 1, 2015, and ending June 30, 2016, to appropriate funds in the aggregate amount of \$31,500, which consists of \$29,000 in grant funding from the Virginia Department of Emergency Services for the emergency response team, and a \$2,500 donation from the Walmart Foundation for the Kids After School Program. To amend the Capital Projects Fund Budget to unappropriate \$250,592 from VDOT Safe Routes to School Programs for sidewalk design and construction.

A RESOLUTION NO 16-5 (UNANIMOUS PASS)

A Resolution to acquire by condemnation, if necessary certain portions of the following parcel identification numbers: 28000400001, 2800010A26A, 280004000010, 280004000011, 28000500001, 28000500002, 28000500003, 28000500007, 2900010A006, 3100030A11A, 310030A13A, 3100030A017, 3100030A019, 3100030A022, 3100040A006 AND 31000010E001 in fee simple together with certain easements for the Dupuy Avenue Modernization and Improvement Project.

A ORDINANCE NO 16-FIN-4

(First Reading) to amend the General Fund Budget for the fiscal year beginning July 1, 2015 and ending June 30, 2016, to appropriate funds in the aggregate amount of \$39,752, which consists of \$24,109 in Police Fund Balance Reserves for the purchase of radios for Auxiliary Officers and Animal Control Expenses, \$500 donation from the Dunlop House for Police Auxiliary expenses, \$6,700 from the Library Fund Balance Reserves for the Summer Reading Program and purchase of bicycles from a \$500 donation and \$8,443 from an increase in Victim Witness grant for operating supplies.
