### NOTICE OF WATER USE RESTRICTIONS IN THE CITY OF COLONIAL HEIGHTS AUGUST 20, 2012

Residents and businesses in the City of Colonial Heights are hereby notified that **MANDATORY WATER USE RESTRICTIONS** for city water users will go into effect on **Thursday, August 23, 2012**.

This action is in response to the city's water provider, the Appomattox River Water Authority (ARWA) calling for such restrictions and the Virginia Department of Environmental Quality issuing a "drought warning" advisory for the Appomattox River basin earlier this week.

City water users are advised that the following water conservation measures will be in effect:

- (1) **Paved Areas** - *Washing prohibited except for immediate health and safety requirements.*
- (2) **Swimming Pools**. - *Reduce filling and replenishing to levels to maintain health and safety.*
- (3) **Gardens and Established Landscapes** - *Water only from 8:00PM on Tuesday evenings until 10:00AM Wednesday mornings AND from 8:00 p.m. on Thursday evenings until 10:00 a.m. on Friday mornings AND from 8:00 p.m. on Saturday evenings until 10:00 a.m. on Sunday mornings. Watering of plants can be done with a bucket at any time on any day of the week.*
- (4) **Vehicle Washing** - *Limit noncommercial washing of mobile equipment to Saturdays only using a handheld hose having a positive (i.e., automatic) shutoff nozzle. Commercial mobile equipment washing businesses are exempt.*
- (5) **Restaurants** - *Serve water to customers only upon request.*
- (6) **Public Utilities** - *Conduct sewer and hydrant flushing only to the extent required to meet immediate health and safety needs.*
- (7) **New Landscape** - *Water unrestricted during the first thirty (30) days after planting and shall conform to subsection (3) of this Section after the first thirty (30) days.*

Section 277-22 of the City Code provides penalties for violations of these water use restrictions. A warning is issued for the first offense. A second violation has a \$50 civil penalty, a third violation has a \$100 penalty, and fourth and subsequent offenses carry a \$200 civil penalty. These penalties are assessed on the water bill of the offending customer.
